 - Direct Care Worker Certification home care skills
 - Approved under new national health care system
- Nursing Building
 - Nursing Assistant, Phlebotomy, etc.
- Federal Grant
 - o GARA
 - Increase enrollment for low income and 1st college student in family
 - WRV Center will be the main office
 - Interest in Cibeque and Canyon Day locations
 - Partner with White Mountain Higher Education Department
 - Caution –depending on budget
- Biology Classes
 - Needs min of 10 students
 - Class has been dropped in the past due to low enrollment
- Community Members
 - Need to promote tribal members in staff, administrator, and instructor positions
- Education Cost
 - 1/3 fewer students paid by 3rd party
 - Need to fund students but funding availability has decreased
 - o January 2014 GED cost will increase and go online
- Pell Grant
 - Changed funding based on semesters, not credits
 - 10% full-time student at WRV Center
